

## VISITING JOCKEY APPLICATION

You may obtain a Visiting Jockeys Licence if:

1. You hold a current jockeys licence with a recognised racing control body.
2. You intend to ride thoroughbred horses in Queensland, in races on which betting is conducted.
3. You are not currently under suspension or any other restriction.

### Overseas Jockeys

1. You must complete a Visiting Jockey Licence Application and pay the \$171 application fee.
2. Public Liability insurance fees must be paid as required, before race riding.

The holder of a Visiting Jockeys Licence may participate in:

- races
- barrier trials
- jump outs; and
- general trackwork sessions.

Completion of the written application form involves attaching:

- payment of the application fee, being \$171 (in the form of credit card details, cheque or money order)
- proof of your current jockeys licence.

## VISITING JOCKEY DECLARATION

1. All information that I have provided to Queensland Racing Limited (QRL) in this application form is true and correct in every particular.
2. I understand that QRL will rely upon the information that I have provided in this application form for the purpose of determining whether I am an appropriate person to receive a visiting jockeys licence.
3. I understand that QRL may take disciplinary action against me in the event that the information I have provided in this application is false or misleading in any particular, and that disciplinary action may include the revocation of any licence issued to me.
4. I have read the Australian Rules of Racing and QRL's Local Rules of Racing ("the Rule of Racing") and it is my obligation as a jockey to update myself in relation to QRL's policies and any rules changes and to abide by those policies and rules of racing.
5. I am not currently subject to any disciplinary action initiated by another Principal Racing Authority (PRA) in Australia or Overseas and I will immediately inform QRL should any PRA in Australia or Overseas initiate disciplinary action against me.
6. I understand that if I do not pay any amount owed to QRL within the required time, QRL may set off this debt against any prize money due and owing to me through the Central Prize Money System (CPS) administered by QRL.
7. I authorise QRL to make deposits via Electronic Funds Transfer (EFT) into the bank account nominated by me in this application form. I understand that if my bank account details change, I will have to notify QRL in writing of the new bank account details and that until I notify QRL in writing of the change, QRL may still make deposits into the account nominated in this form.
8. For GST purposes relating to the supply of services by me (the Supplier), to QRL (the Recipient):
  - (a) I, (the Supplier) acknowledge that I am registered for GST purposes and I will notify QRL in writing if I ceased to be registered for GST purposes;
  - (b) I, (the Supplier) will not issue tax invoices in relation to any prize money (supplies) that QRL may have to pay me;
  - (c) QRL, (the Recipient) can issue tax invoices in respect of prize money (supplies) that it has to pay me;
  - (d) I, (the Supplier) will not issue tax invoices on respect to supplies;
  - (e) I understand that QRL is registered for GST purposes and that it will notify me in writing immediately if it ceases to be GST registered or it is otherwise unable to prepare Recipient Created Tax Invoices (RCTI) on my behalf;
  - (f) I understand that QRL can only issue an RCTI on my behalf if it complies with the requirements established under legislation.
9. I authorise QRL to disclose information provided by me in this application form to:
  - (a) All PRA's in Australia and Overseas;
  - (b) The persons specified in this application form;
  - (c) State and Federal Government departments and regulatory authorities;
  - (d) Persons currently unknown for the purpose of complying with statutory obligations requiring QRL to disclose information.
10. I consent to QRL contacting all licensed totalisator operators and licensed racing bookmakers in Australia and Overseas, for the purposes of determining whether I am betting on races. I also consent to those third parties disclosing information to QRL about any betting that I engaged in.
11. I consent to QRL contacting other Australian and Overseas Racing Control Bodies and I consent to those bodies disclosing any information that may be registered at any time by QRL.
12. I acknowledge that QRL collates personal information about me as part of its licensing and disciplinary processes and when auditing my performance as a visiting jockey. I authorise QRL to disclose information relating to my disciplinary history in Queensland to other PRA's in Australia and Overseas.
13. I understand that if I make misleading statements to QRL, that I will be subject to disciplinary action that may result in the revocation of my visiting jockeys licence.
14. I authorise QRL to place the necessary personal details in the Queensland Racing Magazine enabling persons to contact me.
